Minimum Qualifications:

1. Must be at least eighteen (18) years of age and have a High School Diploma or Equivalent.
2. Applicant must satisfy the Joint Committee that they have sufficient education to take the related instructions.
3. Proof of residency in jurisdictional Counties: ie: drivers license or utility bill

5. **Proof of residency in jurisdictional counties: (i.e. drivers license or utility bill)**

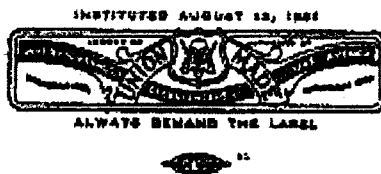
The Apprenticeship term is 10,000 hours, consisting of on the job training, as well as related classroom training, which result in the final status of Journeyman Millwright.

Each applicant who meets all basic requirements will be required to take a written qualifying and a mechanical aptitude test. After passing the written qualifying and mechanical aptitude tests, the applicant will then be interviewed by the Apprenticeship Committee. The interviewers will consider: work habits, interest in construction work and cooperativeness.

Apprentices will be selected in order of the ranking resulting from the rating of the interviewers. All successful applicants will be required to pass a physical examination and to submit to a substance abuse test. The applicant and the committee will share the cost of the physical examination and substance abuse test equally.

All applicants will be considered without regard to race, color, religion, national and ethnic origin or sex.
